

Kiwanis Sea Cliff Mini Mart Vendor Information - Sunday, Oct 4th 2026

Mini Mart is dedicated to supporting local artists, Sea Cliff Avenue businesses, and local nonprofits that utilize it for non-political fundraising. It is the largest fundraiser for the Kiwanis Club of North Shore Long Island, enabling us to support children through programs such as Klothes for Kids, food drives, Camp Kiwanis, Momma's House, and pediatric trauma kits for the fire departments.

LOCATION: Sea Cliff Avenue from Carpenter to Prospect Ave.

BOOTH INFORMATION:

Booth size: 15' x 6'. (A 4' wide sidewalk is behind booths). A 10'x10' Tent will fit.

We do not provide tents, chairs, tables, or electricity. There are a few booths where a sidewalk is blocked. We are not responsible for newly placed village trees, receptables, etc.

Tent weights: Vendors must be equipped with tent weights that comply with the manufacturer's recommendations for the tent, as weather conditions may require it. For the safety of you, neighboring vendors, attendees, and your merchandise, it is essential to have weights to secure your tent in the event of excessive wind. If weather conditions necessitate it, vendors who fail to provide tent weights and tie-downs will not be permitted to attend the show, and no refund will be issued. The Kiwanis Club of North Shore Long Island assumes no responsibility for the acts or omissions of its vendors.

Vendor Layout and Positioning:

We consider several factors when selecting a vendor placement. It is a painstaking process, but we hope to maximize your potential success. Location input includes:

Local Artists. We make efforts to feature local artists to ensure a varied and exciting offering.

Street Businesses on Sea Cliff Avenue have space in front of their establishments. If a new store opens in your current location, we will need to relocate you, but we will try to keep you in the same general area.

Returning vendors. We appreciate returning vendors' requests for the same location; please refer to the information above.

Requests to be next to another vendor. If you ask to be together, be aware you may be relocated from your original spot as the surrounding booths may already have your friends offering.

Like Merchandise: It is essential that you send photos or websites of your products and clearly indicate all that you are offering, so we can avoid placing vendors with similar merchandise next to each other.

Weather Considerations: Threatening weather? We will email you and post on our Facebook page for fair updates affecting the event. It is your responsibility to regularly monitor your email and Facebook for the latest updates. This is a Rain-or-Shine event. In the event of ordinances or requirements issued by a state, county, or village, we will cancel the Mini Mart and refund booth monies, minus a nominal handling fee of \$10.00.

STREET MUSIC: Street music areas are restricted due to crowd flow and safety concerns. Currently, there are three designated approved areas where music can take place. The bands are booked by the three previously approved vendors.
